**ORDER PERTAINING TO THE ASSIGNMENT OF
CASES AND PROCEEDINGS**

The United States Court of Appeals for the Sixth Circuit has appointed Bankruptcy Judges Marci B. McIvor, Phillip J. Shefferly and Thomas J. Tucker in this district. This administrative order sets forth the reassignment of the Court's cases and the procedure for assigning new cases. It is entered pursuant to 28 U.S.C. § 154(b) and Local Bankruptcy Rule 1071-1(f).

Accordingly, it is ordered that:

1. **Chapter 11 Cases in Detroit.** On March 24, 2003, the clerk shall reassign the pending chapter 11 cases as stated on the attached Exhibit A.
2. **Chapter 7 and 12 Cases Presently Assigned to Judge Shapero.** On March 24, 2003, the clerk shall reassign to Judge Shefferly the chapter 7 and 12 cases that are presently assigned to Judge Shapero, except that the cases on the attached Exhibit B shall be reassigned to Judge McIvor.
3. **Chapter 13 Cases Presently Assigned to Judge Shapero.** On March 28, 2003, the clerk shall reassign to Judge Shefferly the chapter 13 cases that are presently assigned to Judge Shapero.
4. **Chapter 7, 12 and 13 Cases Presently Assigned to "Successor to Judge Graves."** On March 24, 2003, the clerk shall reassign to Judge Tucker the chapter 7, 12 and 13 cases that are presently assigned to "Successor to Judge Graves."
5. **Chapter 13 Cases Presently Assigned to Judge Rhodes.** On March 28, 2003, the clerk shall reassign to Judge McIvor the chapter 13 cases that are presently assigned to Judge Rhodes.
6. **Assignments of New Chapter 7 Cases.** On March 24, 2003, the clerk shall begin randomly assigning chapter 7 cases such that (1) the judge not assigned chapter 13 cases pursuant to paragraph 8 below is assigned an increased proportion, to be determined periodically in

consultation with the chief judge, that accounts for the fact that the other three Detroit judges will then be assigned all of the chapter 13 cases, and (2) the remainder of the chapter 7 cases are divided equally among the three judges who are assigned chapter 13 cases. Initially, the proportions of chapter 7 assignments shall be as follows: Judge Rhodes - 40%; Judges McIvor, Shefferly and Tucker - 20% each.

7. **Assignments of New Chapter 11 and 12 Cases.** On March 24, 2003, the clerk shall begin randomly assigning chapter 11 and 12 cases one-fourth each to the four Detroit judges.
8. **Assignments of New Chapter 13 Cases.** On March 24, 2003, the clerk shall begin randomly assigning chapter 13 cases one-third each to Judges McIvor, Shefferly and Tucker. It is the intent of the Court that in turn and in random order, a judge will rotate off the chapter 13 docket at 2 year intervals. Accordingly, when this paragraph has been in effect for 2 years, the clerk shall reassign to Judge Rhodes the chapter 13 docket of one of the other Detroit judges, to be randomly determined. This process will then repeat every two years thereafter.
9. **Bay City and Flint Cases.** On March 24, 2003, the clerk shall begin assigning to Judge Shapero all new cases filed in Bay City and Flint, and the clerk shall reassign to Judge Shapero the cases that are presently pending in those court locations.
10. **Matters to be Retained by Judge Shapero.** The case of Joseph E. Kloian, case no. 99-51514, and the miscellaneous case of Holland v. Dines, No. 91-09, will remain assigned to Judge Shapero.
11. **Reassignment of Adversary Proceedings.** In accordance with L.B.R. 1071-1(e)(3), all adversary proceedings arising in a case shall be reassigned to the judge to whom the case is reassigned, except as otherwise specifically ordered herein.
12. **Authority Retained to Sign Opinions and Orders.** After any reassignment set forth in this order, the judge to whom the case had previously been assigned will retain the authority to sign opinions and orders relating to any matters heard, resolved or taken under advisement by that judge.
13. **Conflict with L.B.R. 1071-1(e)(1).** To the extent of any conflict, the provisions of this order supercede L.B.R. 1071-1(e)(1).
14. **A Judge's Unavailability for a Chapter 13 Calendar Docket.** When a judge is unavailable for a scheduled chapter 13 calendar docket, any other judge is authorized to hear, determine and enter orders relating to those matters.

15. **Name of the Assigned Judge on Papers.** Parties are reminded that L.B.R. 9004-2(a)(2) requires that the name of the judge to whom the case is assigned be stated in the caption on each paper filed with the Court. To insure the proper and expeditious routing of papers within the Court, the Court requests strict compliance with this requirement.
