Donald M. Robiner, United States Trustee, Region 9, Michigan and Ohio has appointed, pursuant to 28 U.S.C. §586(b), Krispen S. Carroll and Tammy L. Terry to serve as Standing Chapter 13 Trustee(s) in the Eastern District of Michigan. Ms. Carroll and Ms. Terry will serve in the capacity of Standing Chapter 13 Trustee(s) in addition to David Wm. Ruskin who has served in this capacity since 1982.

Ms. Carroll and Ms. Terry will be substituted as successor trustee(s) for certain Chapter 13 cases filed in 1998, 1999, and 2000, pursuant to 11 U.S.C. §325 and Rule 2012(b) of the Federal Rules of Bankruptcy Procedure. On or about April 1, 2000, Ms. Carroll will be substituted as successor trustee for cases filed in 1998, 1999, and 2000 that are assigned to the docket of the Hon. Walter Shapero. On or about April 1, 2000, Ms. Terry will be substituted as successor trustee for cases filed in 1998, 1999, and 2000 that are assigned to the docket of the Hon. Ray Reynolds Graves.

An accounting of the prior administration of the cases in which Ms. Carroll and Ms. Terry are substituted as successor trustee(s) will be filed and available for review at the Office of the Clerk, United States Bankruptcy Court for the Eastern District of Michigan at 211 West Fort Street, Suite 2100, Detroit, Michigan on or before May 31, 2000.

As soon as practicable after April 1, 2000, but not later than April 17, 2000, an official notice, which will include names and numbers of the cases in which Ms. Carroll and Ms. Terry are successor trustee(s) will be published in the Detroit Legal News, the Oakland County Legal News, and Michigan Lawyers Weekly. The list of cases transferred to the successor trustees will also be available at the Office of the Clerk, United States Bankruptcy Court and on the Bankruptcy Court's web site (www.mieb.uscourts.gov), as well as on the web site of Standing Chapter 13 Trustee, David Wm. Ruskin (www.det13.com).
