QUESTIONS FOR DEBTOR(S) AT 341 MEETINGS OF CREDITORS BY DEBTOR'S COUNSEL

1. Please place your appearance on the record by stating your name and the law firm with which you are a member. *If you are not a member of the Firm that filed the case, please state:*
 - a. The firm you work for, and
 - b. Whether you have filed a Notice of Special Appearance and Statement of Attorney for debtor(s)
2. Indicate on the record that you have reviewed debtor's government issued photographic identification and have verified debtor's identity **AND**
 - a. that you have provided the Trustee's office with the Declaration of Identity Form prior to Today's hearing, **or**
 - b. that you have not provided the Trustee's office with the Declaration of Identity Form because_____
3. Indicate that you have compared debtor's social security card with the social security number shown on the Notice of Commencement issued by The Bankruptcy Noticing Center.
4. Did you sign the petition, schedules, statements, the plan, and related documents?
5. Did you **read** the petition, schedules, statements, the plan, and related documents BEFORE you signed them?
6. Debtor attorney to verify on the record that debtor(s) signed the petition.
7. Is the address on the Petition your current address?
8. Is the information contained in the petition, schedules, statements, the plan, and related documents a full and complete disclosure of all your assets and everything you own? Is this information true, and correct? Are there any errors or omissions to bring to the court's attention currently?
9. Have you listed all your liabilities and everyone you owe money to?
10. Have you filed tax returns for the last four (4) calendar years preceding the commencement of this case?
11. Tell us your sources of income.
12. How often are you paid? (Weekly, Biweekly, Semi-monthly, Monthly).
13. Have you received within the last year an inheritance, severance pay, employment bonus, profit sharing, payments from a pension plan or any additional income other than the income disclosed on Schedule I? If yes, state how much and the source of the income.
14. Do you expect to receive an inheritance, severance pay, employment bonus, profit sharing, payments from a pension plan or any additional income other than the income disclosed on Schedule I for the next five years? If yes, state how much and the source of the income.
15. Do you currently have any other legal matter being handled by an attorney other than your bankruptcy attorney? If yes, please state the nature of the matter and the name of the attorney.
16. Do you anticipate needing the services of an attorney other than your bankruptcy attorney over the next five years? If yes, please state the nature of the anticipated matter and the attorney, if any.
17. Have you lived in Michigan continuously for the past two years? If not, where else have you lived?
18. What is your marital status? (If divorced, what year was the divorce judgment entered?)
19. Have you previously filed for bankruptcy?
20. Do you have insurance on your property to the extent required by contract or statute?
21. Do you understand that you are required to always carry insurance during your chapter 13 case?
22. Do you have a Domestic Support Obligation (DSO)?
23. Please proceed with any other questions relevant to the case.
